VI. SLATE update Glen Wasik & Huan Yan

SLATE is a 3<sup>rd</sup> party software purchased in 2018 to support admissions and CRM with future admissions. Exclusively used in Higher Ed.

Hosted by Amazon web services

Used by both undergraduate and graduate admissions (added in 2019). The

Med, Pharmacy and Law schools uses another tools.

Used it to load undergraduate and graduate information into Banner.

Provided the group with a demo of what a student would see during their application process. Glenn showed how the application process works and how the exception reports on applications and other issues.

- VII. Kurt Kruschinska gave a brief overview on how the new Waitlist process works. Discussed some of the new issues. A department could set up multiple sections within a course to be wait listed. Students, for various reasons, can pick multiple wait lists. He noted that technically there is a way that we can stop it; we can allow a student to only waitlist onto one section at a time.
  - Since the meeting, the WL has now been added to one of the classifications in STARS. This will allow chairs/departments/advisors to run reports.
